

# **ISO:IEC** 17025 : 2017 Laboratory Competence

#### WHAT IS ISO/IEC 17025?

ISO/IEC 17025 specifies the general requirements for the competence to carry out tests and/or calibrations, including sampling dictated by international methods. The standard identifies the high technical competence and management system requirements that guarantee your test results and calibrations are consistently accurate. The standard covers assuring the quality of test and calibration results to environmental conditions and purchasing.

In addition to establishing a quality system, documentation and personnel requirements, ISO/IEC 17025 directs calibration labs to:

- Investigate the uncertainty of each measurement.
- Incorporate the uncertainty into the test procedure and/or test limits.
- Provide the uncertainties with the calibration certificate and results.

Reporting the uncertainty qualifies the accuracy of the measurement and aids understanding when comparing results from different labs. The ratio of specification-to-calibration uncertainty is a way equipment users gauge their confidence in a product's performance.

#### WHO NEEDS ISO/IEC 17025?

Any laboratory wishing to demonstrate its technical competence and the availability of technical resources to produce reliable data and results for a defined test, measurement or calibration can benefit from an ISO/IEC 17025.

A growing number of industries require ISO/IEC 17025, but all laboratories carrying out tests and calibrations must conform to the general requirements for competence in laboratory environments. ISO/IEC 17025 applies to all laboratory environments, regardless of the number of employees or the extent of the testing, some of which include automotive, cosmetics, microelectronics, petrochemical, pharmaceutical and power generation.
