WHAT IS ISO 22301?

An ISO 22301 Business Continuity Management System (BCMS) provides a framework to help you create or improve your business continuity plan, enhance resilience and decrease disruptions to business performance in any period of uncertainty. A BCMS specifies requirements to plan, establish, implement, operate, monitor, review, maintain and continually improve a documented system to prepare for, respond to and recover from disruptive events when they arise.

Business Continuity Management provides an effective response by identifying potential threats to an organisation and their possible impact on business operations. This framework safeguards your reputation, profitability and the interests of key stakeholders.
